KENKO Mayonnaise Co., Ltd. (Headquarters: Suginami-ku, Tokyo; President and Representative Director: Takashi Sumii) is pleased to announce our endorsement of the recommendations of the Task Force on Climate-related Financial Disclosures (TCFD)\* and our disclosure of information on the Company's corporate website in line with TCFD recommendations.



In accordance with our company philosophies of "Contributing to the world by providing quality foods" and "Body and Mind (mind/body/soul) and Environment" the Group aims to create a sustainable society and, to this end, formulated a Sustainability Policy in 2021. On the basis of this Policy, we have focused on reducing CO<sub>2</sub> emissions and waste output, implementing a variety of measures such as maintaining net-zero emissions at all Group factories, reviewing our production processes, and improving energy efficiency. In 2022, we went on to establish our Sustainability Promotion Office, and we continue to further enhance our sustainability initiatives.

Climate change poses major business challenges to the activities of the KENKO Mayonnaise Group, and we have therefore announced our endorsement of the TCFD recommendations. We have worked to identify, evaluate, and consider responses to the risks and opportunities tied to climate change that will affect our operating environment, and have disclosed our findings in line with TCFD recommendations.

It recommends that companies and other bodies disclose information in the four thematic areas of Governance, Strategy, Risk Management, and Metrics and Targets, with relation to climate-change risks and opportunities.
